King's College Doha: Parental Conduct Agreement

Introduction

This Parental Conduct Agreement aims to promote a respectful and collaborative environment that ensures the well-being of everyone in our school community.

We believe that all communication between parents, school staff, and pupils should reflect the values and standards of respect, responsibility, and integrity. By enrolling your child at King's College Doha, you agree to adhere to the following terms of conduct.

Respectful Communication

Parents should communicate with school staff, teachers, and administrators in a respectful and constructive manner. Any form of harassment, verbal abuse, or aggressive behaviour will not be tolerated.

- Face-to-face meetings: Scheduled by appointment and conducted in a respectful tone.
- Written communication: All emails, notes, and social media interactions must be polite and professional.
- School events: Behaviour at school events should be courteous, with respect shown to all staff, pupils, and other parents.

School Policies and Procedures

Parents are expected to support and follow the school's rules, policies, and procedures, including but not limited to attendance, uniform, discipline, and curriculum guidelines.

- Ensure your child adheres to the school's uniform and behaviour expectations.
- Respect the school's policies on homework, punctuality, and attendance.
- Engage with the school's code of conduct and disciplinary policies and cooperate with staff in resolving any behavioural or academic issues.

Constructive Feedback

While feedback is welcomed, it must be given in a constructive and respectful manner. Parents are encouraged to follow the appropriate channels for raising concerns or suggestions.

- Address any concerns through the designated communication channels (e.g., parent-teacher meetings, written communications to administration and in person meetings).

- Refrain from public criticism of school staff, policies, or pupils via social media or other platforms such as WhatsApp.

Social Media Use

Parents must be mindful of the impact of social media on the school community. All posts regarding King's College Doha, its staff, and pupils should reflect a positive and respectful tone.

- Do not post inappropriate or harmful comments about the school, staff, pupils, or other parents on social media.
- Avoid posting photos of other pupils without parental consent during school events.

Parental Involvement and Support

We encourage parents to actively participate in their child's learning and school life. However, involvement must align with the school's expectations and boundaries.

- Support your child in their academic and extracurricular activities without undermining the authority of teachers and staff.
- Attend school events, meetings, and parent-teacher conferences as required.
- Offer help in school activities when appropriate and do so under the guidance of the school's leadership.

Conflict Resolution

In the event of a disagreement or conflict, parents are expected to resolve matters in a calm, patient, and constructive manner.

- Follow the school's complaint and dispute resolution procedures.
- Address conflicts privately and directly with the school, avoiding public forums or discussions with other parents that could escalate issues.

Safeguarding and Confidentiality

Parents must respect the privacy and safeguarding of all pupils.

- Confidentiality regarding children's academic and personal information must be maintained.
- Parents should not approach other children or engage in discussions about discipline or behaviour outside the school's protocols.

School Grounds Conduct

- Refrain from entering the school atrium or corridors without a pre-arranged meeting during the working hours of the school day.

Breach of Agreement

In the event of a breach of this agreement, the school reserves the right to take appropriate actions, which may include:

- A meeting with school leadership to discuss concerns.
- Restricted access to the school premises or events.
- Formal written warnings.
- In severe cases, consideration of terminating the child's place at the school.
